Prisoners and Pitt Students Both Learn in Law School's Inside-Out Class

Led by Professor David Harris, Pitt Law is one of only a handful of law schools in the country with a class that's part of the Inside-Out Prison Exchange Program, bringing 14 law students last fall to the State Correctional Institute in Greene County for a weekly class alongside 14 incarcerated men. Harris learned about such courses when he interviewed the program creators on his podcast, "Criminal Injustice," a few years ago. "My hopes were that we would create a real learning community inside," he said — to have both groups act as peers to one another "and to give each other the kind of respect and dignity that all of us crave on the outside, but those on the inside don't always get. And I hope the inside students will feel, at least for those hours ... that they were just as important as anyone else ... that they were being treated as people with worth, that they had experiences in life that counted." Professor Greer Donley was selected for the Chancellor's Distinguished Research Award in the Junior Scholar category at the University of Pittsburgh. Chancellor Gallagher said Donley's "scholarship on reproductive rights is creative and visionary." He continued, "[Her] peers identified [her] as a shining light among junior law professors around the country and a leader among a cohort of abortion law scholars."

Professor David Harris received the Chancellor's Distinguished Public Service Award at the University of Pittsburgh. The award recognizes Harris's years of service on multiple commissions and task forces concerning public safety, providing expertise on criminal justice issues in testimony to public bodies and the media, teaching an Inside-Out class combining law students with incarcerated individuals, and incorporating these efforts into both teaching and scholarship.

Professor Mike Madison co-edited the fifth book in the Knowledge Commons series, *Governing Smart Cities as Knowledge Commons*, with Cambridge University Press. This volume deepens our understanding of community governance institutions, communities' social dilemmas, and the dynamic relationships between data, technology, and human lives.

Professor Ann Sinsheimer has been awarded a Pitt Momentum Funds Teaming Grant for her project, with co-investigators from LRDC and the School of Education, "Testing the Effectiveness of Faculty as Facilitators of Psychosocial Resilience Interventions for Students in Professional and Graduate Programs. Sinsheimer's project was one of only two to receive an award at the Teaming Grant level.
