



## FACULTY NEWS

**Professor William M. Carter Jr.**'s article, "[The Second Founding and Self-Incrimination](#)" was published by the Northwestern Law Review. The article explores the self-incrimination doctrine through the lens of enslaved persons and argues for broader Fifth Amendment protections.

**Vice Dean Jerry Dickinson's** article, "[A Theory of Federalization Doctrine](#)," in the Dickinson Law Review sets forth a justificatory theory of federalization doctrine by arguing that the doctrine emanates from the founding generation's practices of consulting and borrowing the pre-Republic states' judicial opinions, constitutions, and statutes to draft and interpret the federal Constitution and its Bill of Rights.

**Professors Ronald A. Brand** and **Charles T. Kotuby** published an [op-ed in the Pittsburgh Post-Gazette](#) about the importance of international law. They discussed real situations in places like Ukraine and Gaza, where people wonder if international law works, especially when there is no powerful group to enforce it.

**Professors John Linarelli** and **Christian Powell Sundquist** were elected Fellows of the American Bar Foundation.

**Associate Dean Ann Sinsheimer** has been awarded a grant from Pitt's Year of Discourse & Dialogue. This grant will support "First Amendment Rights Teach-In," a program she

conceptualized and developed with Allie Linsemeyer, Vincent Johnson, and Pitt's Associate Provost and Dean of Students Carla Panzella.

**Professor Greer Donley** and her colleagues delve into an analytical exploration of the statutory schemes brought into play by the leading states of the "shield laws" movement: California, Connecticut, Delaware, Illinois, Massachusetts, New Jersey, and New York in their latest Journal of Law, Medicine & Ethics article, "[Understanding Shield Laws](#)."

**Professor Philip Hackney** [testified](#) before the U.S. House Ways and Means Subcommittee on Oversight at a hearing on the growth of the tax-exempt sector and its Impact on the American Political Landscape.
