**NICOLE APPLEBERRY, JD**  
**UNIVERSITY OF MICHIGAN LAW SCHOOL**

Nicole Appleberry is the director of the Low Income Taxpayer Clinic and clinical professor at Michigan Law. Her research and teaching interests focus on the legal issues involved when vulnerable populations are caught up in systems beyond their experience and meaningful control—thus the intersection of tax law with other specialties such as poverty, disability, and domestic violence law; the empowerment of adversaries through mediation; and advancing social justice and developing legal skills through dialogue.

His research aims to understand social behavior with an eye toward strategies to change behavior in socially constructive ways.

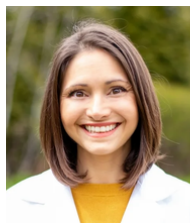
**OMID FOTUHI, PhD**

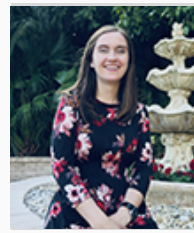
**LYNN BOEPPLE SU, JD**
