AMICUS BRIEFS (DRAFTED)

December 2015. Amicus Brief filed together with Geoffrey Hoffman, University of Houston, in support of Cornell Law School clinical students denied access to represent clients in Immigration Court. The three appeals supported by the Pitt Immigration Law Clinic and the University of Houston Law Center Immigration Clinic were granted overturning the immigration judge's decision. More than 50 Immigration Law Clinics joined the Brief.

February 2017. Amicus Brief filed together with Geoffrey Hoffman, University of Houston, and the Florence Immigrant Refugee Rights Project in support of a Pennsylvania Immigrant Resource Center case that involved an important issue of due process and family separation inasmuch it involved a man who arrived at a land border with his family members, a wife and their children, but was detained at the border after seeking admission. The other family members were able to be released after they passed their credible fear interviews as did the detained father. The Immigration Judge terminated the case to allow the family to reunite and apply for asylum jointly. The Government appealed.
