2022 COMMENCEMENT SPEAKER DAWNE S. HICKTON (JD '83)

University of Pittsburgh School of Law alumna Dawne S. Hickton most recently served as the former Executive Vice President and Chief Operating Officer of Critical Mission Solutions, a 5-billion-dollar government national security, cyber, and space consulting business at Jacobs Engineering Group, Inc. Hickton led the Federal Government Relations, International Relations, and Technology and Innovation teams in addressing the growing demand for advanced, technology-driven solutions. She is also one of few women business leaders representing a large publicly traded firm.



Prior to Jacobs, Hickton was the first woman to run RTI International Metals, a global, publicly-traded, billion-dollar supplier of advanced titanium and specialty metals. Under her leadership, RTI evolved into one of the world's largest metal manufacturers in the aerospace industry.

Upon graduating from Pitt Law in 1983, Hickton began her career as a trial attorney with U.S. Steel. She returned to the law school as a clinical faculty member and director of its corporate counsel clinic while working at Burns, White, and Hickton. Hickton and her husband and fellow Pitt Law alumnus David Hickton (JD '81) established a \$1 million endowment for the school's Elder Law Clinic. The Hickton Elder Law Clinic was named in honor of her late mother-in-law, Gloria McDermott Hickton. At Pitt Law, Hickton received the Dean Sell Award for Excellence in Corporation Law, and she and her classmate won the Pitt Law Gourley Cup Moot Court Competition.

Hickton was named a Top 100 STEM Leader by STEMconnector, a consortium of businesses, organizations, and universities that connect thought leaders on issues related to science, technology, engineering, and math. Her extensive resume includes a stint on the executive committee of the Aerospace Industries Association, a Washington, D.C.-based organization supporting the U.S. aerospace and defense industries. Hickton serves as a board member of the Smithsonian National Air and Space Museum, has also served on and chaired the Board of Directors for the Federal Reserve Bank of Cleveland, and is an emeritus member of the University of Pittsburgh's Board of Trustees. She currently serves as the chair of the Board of Visitors for the School of Law.

University of Pittsburgh School of Law graduate Margaret (Peggie) Dunklin passed away peacefully on Dec. 7, 2021. Peggie graduated from Pitt in 1988 with a bachelor's degree in Communications and earned her Human Resources Online Graduate Certificate in 2020. She worked for the University of Pittsburgh for 33 years.



Peggie spent her entire life as a "Pittsburgher," serving Pitt for 33 years in various jobs and leadership roles, with the last nine years as Director of Budget and Human Resources for the Office of Admissions and Financial Aid (OAFA). Pitt achieved unprecedented undergraduate enrollment success during her tenure. The OAFA team credits that success to Peggie's extraordinary work to support the University's enrollment goals. Blue and gold were part of her soul...right to the very end, Peggie cheered for Pitt, with everyone holding hands and singing Sweet Caroline before she passed.

This afternoon, Pitt's Chief Enrollment Officer Marc Harding will present Peggie's family with an honorary MSL degree.
